Enclosed is a Report (#N1563269 – 01) of the results for testing conducted on Critical Mass Flower from August 13, 2015. The report contains the original testing in which the Mold Count results exceeded the specification (38,000 per gram; with an acceptable level being $\leq 10,000$ per gram).

Product was contained in four (4) bins and results of Mold (Report #N1563356 – 09,10,11,12) showed three (3) bins with low numbers (2,000, 1,400 and 1,600 respectively), and the fourth bin (our sample #11) with an elevated count (20,000) still out of specification. It appears that the fourth bin (sample #11) contained product with elevated levels of mold, and confirmatory testing might be advisable for this bin.

The mold noted was of the genus *Penicillium*, which is the most common atmospheric mold in this area, and is non-toxigenic.

The source of the out-of-specification count may be linked to an isolated and localized contamination of a small number of plants.
