- (S) 5a(2)(c) Four children require updated immunization records
- (S) 19a-79-4a(c)(2) Staffing, two staff present - operator failed to have two staff present with children in attendance when one staff left premises to transport child to program from location off site. One staff present with four or less children according to admin.
- (S) 19a-79-9a(b)(1)(d) Administration of medications, injectable med training - Operator failed to have a currently trained individual who can administer an emergency injectable medication.
- (S) 19a-79-9a(b)(5)(c) Administration of medications, storage and labeling - Operator failed to have child's emergency medication stored in an easily accessible place when staff had to leave child care area to get child's med when requested. Staff gone for over 3 minutes to find medication. Order for Benadryl is on site and no Benadryl was observed at program.
