AFFIDAVIT: VOLUNTARY SURRENDER OF LICENSE

LUZ MEDINA, being duly sworn, deposes and says:

1. I am over the age of majority and understand the obligations of an oath.
2. I make this affidavit on the basis of personal knowledge.
3. I am licensed by the Connecticut Office of Early Childhood ("Agency") to operate a family child care home. I presently hold family child care home License # 56322.
4. I hereby voluntarily surrender my license to operate a family child care home in the State of Connecticut to the Agency.
5. I agree that the surrender of my license is in lieu of the Agency issuing charges against me which allege violations including, but not limited to, §§ 19a-87b-5 (b), 19a-87b-5 (j), 19a-87b-6 (e), 19a-87b-7 (b), 19a-87b-8a, and/or 19a-87b-10 (k) of the Regulations of Connecticut State Agencies, which are connected to an inspection and/or investigation begun on or about August 11, 2022, related to the health, safety or welfare of children in my care.
6. I agree that if, at any time in the future, I apply to the Agency for a new license or seek to reinstate the license I am currently surrendering, the allegations referenced above shall be deemed true.
7. I agree that I am waiving any and all rights I have to challenge the allegations above including but not limited to my right to a hearing before a hearing officer who would determine if the Agency has proven these allegations. I agree and waive my hearing rights including the right to have the evidence supporting the allegations produced and my right to challenge that evidence, including the right to cross-examine the Agency's witnesses, and my right to present evidence and argument on my own behalf.
8. I agree that the surrender of my family child care home license shall become effective by the close of business on September 9, 2022.
9. I agree that the Agency shall have absolute discretion concerning the issuance or reinstatement of my license and whether, if issued or reinstated, said license shall be subject to conditions upon issuance or reinstatement. I agree that I am waiving any right to a hearing regarding the issuance or reinstatement of my license. I further agree that I am waiving any right that I may have to appeal or otherwise challenge the disposition of any such application or request as described above.

12. I agree that this Affidavit has no effect unless and until the Agency accepts it and, if a hearing has been scheduled, upon the Commissioner's granting of the Agency's motion to withdraw the charges.
13. Within twenty-four (24) hours of my receipt of a copy of this fully executed Affidavit, I agree to notify the parents of day care children under my care that I have voluntarily surrendered my license.
14. I agree that I have the right to consult with an attorney prior to signing this Affidavit.
