⑤ 19a-79-4a(c)(2) Two staff on premises at all times - Operator failed to have 2 staff present while children were in care when on 11/18/22, one staff was present caring for children from 6:20 AM until a second staff person arrived at 8:12 am. This was observed on review of program video.

⑤ 19a-79-10(c)(2) Under three, ratios - operator failed to maintain 1:4 ratio for children under three when it was observed that 1 staff was in room with 5 babies upon arrival. During review of class video on 11/15/22, one staff was with a mixed group with 5 children, including a baby, which exceeds the 1:4 required ratio.

③ 19a-79-10(j) Babies held for bottle feeding - staff failed to hold baby for bottle feeding when baby was observed to be laying on boppy pillow + drinking a bottle.
