Cannabinoid	Dry-weight percent (w/w)
Δ^9 -Tetrahydrocannabinol Acid (Δ^9 -THC-A)	30.8%
Δ^9 -Tetrahydrocannabinol (Δ^9 -THC)	0.25%
Cannabidiol Acid (CBD-A)	<0.10%
Cannabidiol (CBD)	<0.10%

Dry-weight percent cannabinoid content = wet-weight percent cannabinoid / (1 – percent moisture / 100)

"wet-weight" means the weight of the sample as it was collected from facility.
