

#55 One child due to overdue physical has outdated vaccine record and missing evidence of flu shot for the season.


#77 Sleep arrangements not posted. Form printed at visit.

- A verified form for a medical exemption must be on file. form is on ct.gov website. No more religious exemptions accepted.


