⑤ 19a-79-3a(b)(3) Overall management + operation of child care center
Operator failed to employ sufficient staff in accordance with applicable state + local laws and regulation when it was observed that children are shuffled for a period of two hours or more from room to room. Children's morning routines were interrupted over and over when individual children were brought in and out of rooms, when groups of children were brought into different rooms as they were trying to eat breakfast, and It was reported by staff that this happens every day and the shuffling of children occurs each afternoon in a similar manner.

⑤ 19a-79-3a(a) Ensure health + safety - operator failed to ensure health + safety of children in care when a person without a background check completed was caring for a group of four children and another staff without a background check was working with infants.
