

#23 observed outdoor ^{play} equipment not secure; observed motor boat engine leaning against outdoor wall; observed glass fish tank on side wall outdoors

 handwashing

#29 observed area in basement set up as infant sleeping / diaper changing area not to have two means of escape. Applicant removed items from room during exit interview - if no two means of escape is done area can not be used for child care! if going to make changes (window/wall etc) notification of change and reinspection.

#32 observed incomplete written evacuation plan
