#16 Substitute failed to use good judgement when leaving children unsupervised more than once and even after Licensing Specialist discussed supervision regulation with substitute and provider



#21 Provider does not have evidence of current background check for herself, substitute and household members; provider stated son has not conducted background check and resides

#57 observed ^{missing} documentation of authorized release for 2 out of 3 children enrolled/present

#58 observed ^{missing} documentation of arrangements for transitioning children to and from school regarding bus pick up and drop off

#63 provider stated she does not have any indoor play equipment when licensing specialist inquired where the indoor toys, books etc were. outdoor play equipment is sufficient

#69 observed missing documentation for care plan enrolled/present with special needs

#77 observed requirements for sleep arrangements not available nor posted during visit

#81 observed children go outside without supervision upon specialist arrival; observed substitute come indoors to get water and leave child outside unsupervised even after discussing regulation requirements.
