

21 Applicant failed to maintain evidence at the family child care home of compliance with criminal background checks.

The main room has 1 door but the window located in that room does not meet the 20" ^{width} height x 24" ^{width} height ^{ump} minimum requirement. The bottom of that window also measures more than 44" above the floor with no fixed landing available.

31 Did not observe handrail on stairs leading to daycare.

32 Did not observe emergency plan

- #50 observed CPR mask, scissors, tweezers, 1 instant cold pack, 2 inch roller ~~gauze~~ ^{bandage}, band-aids, and 1 roll of hypoallergenic adhesive tape missing from first aid kit
