Observations/Corrections needed:

- ① Local health inspection expired 7.9.23 (send copy)
- ⑤ NO notification of change provided when artificial turf was added to under 3s playground and upstairs music and multipurpose rooms were changed to library and staff lounge.
- ⑨ Fire marshal certificate expired 5.24.23 (Send copy)
- ⑪ 1 staff without medical clearance checked off and 1 without TB test date indicated.
- ⑱ 2 staff without complete background checks and working with children. Another staff member was also working without a complete background check for 2 weeks then left program.
- ⑳ Two staff present at closing were not 18 or older on 10/16, 10/13 and 11/10
- ㉒ Contracts Expired - Social Service, Dental, Dietician
- ㉔ All annual reviews expired for all consultants.
- ㉘ First Aid Kits not complete 1B and Lady Bug A - and all kits are used for indoor and outdoor use.
- ㉚ Teachers lounge has very soiled refrigerator inside and base frame at the bottom is detached from refrigerator. Rolling chair in lounge is very worn and torn. Furniture not secured - Infant A cubby, Infant B small cubby
 Infant A - several staples sticking out on door - ~~1B~~ 1B - child chairs stacked 3 high and accessible to children and 2 bags of child belongings stored on top. 2B - Blue paint on radiator is shredding and peeling off.
- ㉞ Preschool playground has green liner exposed and poses tripping hazard in multiple areas
- ㉟ All staff in both infant rooms stated that infants never go outside at all.
- ㊱ Diaper cream logs in multiple rooms do not have name of ointment indicated on log sheets.
- ㊳ Diaper creams stored low and accessible to children in room 2B

Observations/Corrections needed:

- (119) Infant A - Observed teacher using changing table as a counter. Papers and binders were observed and a bib.
- (125) Multiple rooms do not have enough storage space for child belongings. 1B, 2B, Classroom 5
- (133) Foam objects accessible to children under 3 when not in use. 2A - Foam blocks, letters and puzzle
2B Foam puzzle pieces and blocks, Classroom 3 both sides - foam blocks. - Several under 3s rooms throughout have foam strips on edges + corners of furniture and pieces are missing. Children pull it off as stated by staff. Plastic bags accessible to children in Room 3 under changing table & 2B.

Discussion

- Cots cannot be used for storing bags of bedding and child belongings across the top.
- notification of change forms
- 1 child physical expired
- Verify all accident reports are complete
- Step stools cannot be stored on top of sinks
- * Observed new turf in under 3s playground and library + teachers lounge.
All were compliant today.
