

Observations/Corrections needed:

- Provider states that she's using bathroom upstairs due to the status of tenant's use of bathroom.
- Provider regularly brings children up and down together
- Kitchen is secure, cabinets have locks to bar access to hazards.
- Discussed frequent handwashing as all three children were observed with mild colds/runny noses. Hence downstairs bathroom must be more accessible/ready.
- #22 Bathroom sink observed dirty with splatter of toothpaste or other substance. Unsanitary for children use.
- #23 Hazards observed in bathroom - beer bottles outdoors: glass bulbs
- #24 Harmful substance accessible in bathroom - bleach/clorox bottle outdoors: tiki torch fluid/oil.
- #25 Upstairs bathroom had urine in toilet training seat accessible
- #32 Emergency plan is missing
- #33 Drills not documented all year
- #48 Emergency numbers not available
- #53 Two children missing enrollment form.


