



During today's follow-up visit the following was observed:  
 # 28 - Provider is still working on correcting this violation. It was observed that the TV chord in the infant room has been secured. The white extension chord in the living room has been tucked behind the play kitchen but it is not yet secure as the provider has run out of supplies to secure them.  
 # 39 - Specialist observed there are no more pieces of glass in the enclosed outdoor play area. The walkway that leads from the back door to the outdoor play area was also observed to have no more pieces of glass spread throughout the sidewalk/grass area.  
 # 73 - A crib that is used to nap an infant was observed to have just one tight fitted sheet and not two anymore. The pack n play that is used to nap the other infant was still observed to have a loose/large sheet on the mattress. Provider showed specialist during today's visit that she has ordered the tight fitted sheet and it is scheduled to be delivered this evening.
