

 # 73 - Provider is now using a crib that was manufactured on May 3, 2013 to nap an infant and a tight-fitted sheet was observed on the mattress during today's partial inspection.
 **Provider also showed the specialist that she has additional fitted sheets in the event that she begins caring for more infants.
 **Provider also has an additional crib that is not being used by any children this time. Specialist was able to locate the label on the crib and confirmed it was manufactured on November 20, 2013. This additional crib can also be used in care.
 Provider was observed to be in compliance during today's partial inspection
