The following was observed during today's partial inspection:  
 # 39 - Specialist did not observe pieces of glass in the enclosed outdoor play area or on the sidewalk/grass walkway that leads children from the back door to the outdoor play area.  
 # 71 - Upon specialist's arrival today; provider was observed to be holding an infant for her bottle feeding. Provider remains in compliance with this regulation today.  
 # 73 - Provider was observed to still have a tight fitted sheet on the pack n play mattress that is used to nap an infant. Provider was also still observed to have a tight fitted sheet on the crib mattress that is being used to nap a second infant. Provider remains in compliance with this regulation today.  
 # 74 - Upon specialist's arrival today; an infant was observed to be napping without her bib and the attachment clip for her pacifier still on. Provider remains in compliance with this regulation today.
