

40 - The fence that used to enclose the provider's above ground pool was observed to be locked but the pool has been taken down for the winter.
**Provider was observed to be in compliance during today's visit.
**Provider was reminded that if pool is installed again in the spring she needs to notify the agency and it will need to be inspected by her specialist; notification of change discussed.
**There is also construction going on at the provider's home as her attached garage is being converted into what she hopes to be her new daycare space. Provider previously submitted notification of change for that in 11/2024. Provider anticipates construction will be completed soon.
