

**AFFIDAVIT:  
VOLUNTARY SURRENDER OF LICENSE**

**HIROSHIMA DE JESUS**, being duly sworn, deposes and says:

1. I am over the age of majority and understand the obligations of an oath.
2. I make this affidavit on the basis of personal knowledge.
3. I am the holder of Connecticut Family Child Care License # 57381, issued by the Connecticut Office of Early Childhood (“Agency”) to operate a family child care home.
4. I hereby voluntarily surrender my license to operate a family child care home in the State of Connecticut to the Agency.
5. I understand that the surrender of my license is in lieu of the Agency issuing charges against me which allege violations including, but not limited to, §§ 19a-87b-5 (j), 19a-87b-7 (b), 19a-87b-10 (j) and/or 19a-87b-10 (k) of the Regulations of Connecticut State Agencies, which are connected to an investigation that began on or about February 5, 2025, related to the health, safety or welfare of children in my care.
6. I understand and agree that if, at any time in the future, I apply to the Agency for a new license or seek to reinstate the license I am currently surrendering, the allegations referenced above shall be deemed true.
7. I understand that I am waiving any and all rights I have to challenge the allegations above including but not limited to my right to a hearing before a hearing officer who would determine if the Agency has proven these allegations. I understand and waive my hearing rights including the right to have the evidence supporting the allegations produced and my right to challenge that evidence, including the right to cross examine the Agency’s witnesses, and my right to present evidence and argument on my own behalf.
8. I agree that the Agency shall have absolute discretion concerning the issuance or reinstatement of my license and whether, if issued or reinstated, said license shall be subject to conditions upon issuance or reinstatement. I understand and agree that I am waiving any right to a hearing regarding the issuance or reinstatement of my license. I further understand and agree that I am waiving any right that I may have to appeal or otherwise challenge the disposition of any such application or request as described above.
9. I agree that this Affidavit and the contents of the Agency’s file concerning the above-referenced allegations are public documents and that I am executing this Affidavit in settlement of the allegations contained therein.
10. I agree that the surrender of my license may be reported in accordance with Agency policy and procedure and/or in accordance with applicable state or federal law.

11. I agree that this Affidavit has no effect unless and until the Agency accepts it and, if a hearing has been scheduled, upon the Commissioner's granting of the Agency's motion to withdraw the charges.
12. Within twenty-four (24) hours of my receipt of a copy of this fully executed Affidavit, I agree to notify the parents of day care children under my care that I have voluntarily surrendered my license.
13. I understand that I have the right to consult with an attorney prior to signing this Affidavit.
14. I agree that the surrender of my family child care home license shall become effective by the close of business on the date of notarization.
