was observed, on video, not adhering to the program's discipline and child abuse/neglect Policy. Staff was observed forcefully and aggressively grabbing a child by both arms, pulling child's arm behind the child's back, while at one point placing her left arm around the child's neck to move/redirect child from the Carpet area. Staff was then observed attempting to stop the same child from running away from her by grabbing the child by the arm. The child subsequently ran into a book shelf (as child was trying to get away from staff) ^{hit} his head on the corner of bookshelf and fell to the floor.
