

DISCUSSIONS/COMMENTS

Upon arrival Licensing Specialist observed substitute present with five children present. About one minute later child #6 arrived. Substitute stated that provider was out with two children buying some things. Provider arrived at 10:07am with two children and a few groceries in hand such as hotdogs, fruit and nestle powder milk. Discussed with provider and substitute the severity and importance of the children eating bread while sitting on a nest swing. Substitute removed bread from children and stated she understood child should be sitting and supervised while eating at all times. Observed three children in a "Little Town" blue nest swing. According to manufacturer guidelines it is for children ages 3 years old to 12 years old. One of the three children in nest swing is age two and does not turn three years old until 8/8.
