Furthermore, he requested the necessary documents from her daughter and printed the monitor log during the visit.

# 23 Freedom of Hazard: Provider not in compliance with maintaining the facility and/or equipment in good repair and free of hazards when the OEC representative observed the outdoor gate is chipped and has screw protruding from it. The artificial turf on the playground has many wrinkles that pose a fall hazard.

- \* Two toddler swigs are not secured on the ground.
- \* A trampoline was observed broken. The provider did not have rules for it.
- \* The wooden playground has screw coming out.
