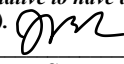

 #24- Ant killer chemical and flammable device were observed on top of the laundry machine. It was corrected during the inspection.  
 #30- Basement level supervision upon arrival a baby was sleeping downstairs.  
 Basement damage in corner wall under the window and bathroom is under construction, visible tools and debris and dust upon entering. Door to be maintained locked to prevent children access to the construction area.
