

**# 68 Proper Rest Provisions- Safe Cribs. In compliance.**  
**Discussion:**  
**(1) Sleep Arrangements for Infants**  
 (1) Infants under twelve months of age shall be placed in a supine (back) position for sleeping in a well-constructed, free standing crib or other piece of equipment designed for infant sleeping and appropriate for the particular infant under twelve months of age, with a snug fitting mattress covered by a tightly-fitted sheet unless the infant under twelve months of age has written documentation from a physician, physician assistant or advanced practice registered nurse specifying a medical reason for an alternative sleep position or alternate piece of equipment.  
 (3) Notwithstanding the provisions of subdivision (1) of this subsection, no items, including, but not limited to, pillows, soft bumpers, toys and blankets, shall be placed with an infant under twelve months of age in a crib or hung over the side of a crib or other piece of equipment designed for sleeping, except for a pacifier without attachments, unless the infant under twelve months of age has written documentation from a physician.  
 The pack and play shall have the base adjusted to the playard floor and covered by a tightly-fitted sheet.  
 During the inspection, the provider removed a large Playard from her daycare.
