 -Importance of ensuring adequate supervision by sight and sound during indoor and outdoor play. Provider demonstrated to licensing specialist the backyard fenced in area where the children play. Provider admitted children have gone on walks in neighborhood around culdesac. Per provider she stated one child cries and doesn't want to come inside so she has stopped the walks and moving forward will only play in the backyard.  
 -Licensing specialist reviewed with provider supervision regulations.  
 -All children enrolled must have complete enrollments documents available in childcare.
