Maintaining compliance with staff and capacity.
That corrections need to be completed as soon as possible and that the corrections are to be sent to licensing specialist by the two week deadline when possible.
Corrective action plans being due, how to complete them and that provider can reach out to either Patricia Tyburski or Alexandra Rodriguez for assistance.
Providers use of staff was discussed explaining that the provider is the primary caregiver and while she can use staff she should be the one, when on site, giving direct care to the children.
Supervision of children while outside and that without supervision children can not enter the home.
