 # 24 - Applicant was observed to have purchased and installed locks for the kitchen cabinets. Applicant also removed the Listerine mouthwash from the bathroom cabinet; it is now on top of the bathroom shelf out of the children's reach.
 # 46 - Water temperature was retaken and it is now 118.6 degrees Fahrenheit.
 # 50 - Applicant was observed to have purchased 4x4 inch gauze squares, a 2 inch gauze roller bandage, 1 roll of hypoallergenic adhesive tape, and 2 instant cold packs for the first aid kit.
 # 66 - Applicant was observed to have created her flexible written schedule.
