DISCUSSIONS/COMMENTS

Discussed with the provider the following:
 -Observed trash can and two brooms next to door leading to outside causing a little narrow walkway.
 -Observed two nails protruding out of a fence panel near children's swing set and an empty caulk bottle near children's swing set.
 -Observed mop bucket outside with some water inside of it.
 -Observed tarp under the swing set posing a tripping hazard (under mulch). Provider stated a gentleman is coming this weekend to fix it up.
 (Children were not playing outside during inspection.) Provider removed all items listed above during inspection and moved trash can and brooms away from emergency exit.
 *Discussed importance of ensuring outdoor space is free from any hazards prior to children playing outside. Provider stated she mainly plays with children on outside gated deck area.
 *Discussed with provider will follow up with BCIS in regards to household member being in (work supervised) status.
 *Discussed with provider if she plans on having her two household members apply to be approved staff, they must follow all OEC requirements such as; current background check status, current medical statement, and must assist provider in caring for children while maintaining compliance in capacity.
