 Observed today a wet area around a wood panel in the far right corner of backyard area that will not be used for the program, with some water around, noticeable today. The area was dry on the day of the initial inspection. Discussed with applicant the need to keep an eye on the area, specially after rainy days.
 Discussed regulations for body of water and possible need to block area according to the regulations, if the area collects and maintains water.
 Approval pending supervisory review.
