



#62 A continuación; Traducción: Provedora no está en cumplimiento con las necesidades físicas de los niños cuando una niña fue servida una comida caliente y sostuvo una quemadura en su mano. Observations/Observaciones: ~ During the OEC representative visit; lunch preparation was observed; lunch consisted of hamburgers, apples cut in small pieces, baked fries, water and milk. Provider served meal on plates and waited for hot items to cool off while children washed their hands, sat down in their respective chairs and then lunch was served. Durante la visita de la representante de la OEC; se observe la preparacion del almuerzo; en cual el almuerzo consiste de hamburguesa, manzanas cortada en pedazos pequenos, papitas azadas, agua y leche. La provedora sirvio la comida en los platos y espero que los articulos caliente se enfrio mientras los ninos se lavaron las manos, se sentaron en sus sillas y el almuerzo fue servido. ~ Notification of change to be submitted to Licensing Specialist within 5 business days if/when making changes within her home which alters or affects the provision of family child care services. Enviar notificación de cambio a especialista dentro 5 días laborales si/cuando hacer algún cambio dentro su hogar que altera o afecta la provisión de los servicios de cuidado de niños. ~ Explained to provider that household member(s) who are not OEC approved staff can prepare meals, clean etc and cannot provide direct care to children. Se le explico a la provedora que miembro(s) del hogar que no son aprobado por la OEC puede preparar comidas, limpiar etc. pero no pueden cuidar a los niños por ejemplo jugar con los ninos, darle de comer, cambiar pañales etc. ~ Send completed witness statements no later than 2 weeks. Enviar las declaraciones no mas tardar de 2 semanas.
