

DISCUSSIONS/COMMENTS

Upon entering the family child care home for a follow-up inspection, the specialist observed a 9-month-old infant asleep in a bouncer in the living room. The provider was holding a 6-month-old infant when she opened the front door of the home to allow the specialist access to the interior of the home for the inspection. The provider swiftly placed the 6-month-old infant she was holding in one play pen then lifted the sleeping 9-month-old infant out of the play pen and placed him on his back in the other play pen. While placing the 9-month-old infant in the play pen, the provider stated to the specialist that the 9-month-old had just fallen asleep in the bouncer. The specialist observed both play pens have tight-fitted sheets on their respective floor mats.
