**DISCUSSIONS/COMMENTS**

During today's follow-up inspection, there were 4 children in total, including one 5-month-old infant. The specialist observed a two-year-old child napping in a safe play pen. The rest of the children, including the infant, were awake during the follow-up inspection. The provider informed the specialist that she places the infant to sleep in the play pen when the infant starts to show signs of tiredness. The provider observed the play pen utilized for infant sleep to be in compliance with infant sleep regulations.
