Observed a printed copy of registry transcript stating expiration dates of first aid and cpr. _-licensing specialist will return to observed playground thoroughly, unable to during inspection due to snow._-Provider understands he must wait until OEC receives results for paint chip sample from ceiling on second floor before attempting to correct it. _-Observed a mattress in crib in childcare. Mattress is not a snug fit mattress, observed a gap. Per provider, he will remove mattress and does not plan to enroll infants yet. _No infants were observed present during inspection.
