DISCUSSIONS/COMMENTS

There were 8 children in total, including one -month-old infant, present during today's follow-up inspection. The provider was accompanied by DCFS.93001. The specialist conducted the walkthrough in the presence of the provider and observed the -month-old infant asleep in a safe bassinet that was free from hazards. The specialist observed the infant asleep in a prone position, "belly down". The provider immediately stated to the specialist that she laid the infant down to sleep on his back and he rolled over onto his stomach on his own. The specialist reiterated that infants younger than 12 months must always be placed to sleep on their backs in a supine position to sleep. If an infant younger than 12 months rolls over independently from their back to their stomach, they may remain asleep in a prone position, "belly down".
