Provider replaced crib that was manufactured in 2010 with a crib that was manufactured in 2020. A tight fitted sheet was in place. Discussed with provider that playard with holes in the mesh should not be used. If manufacturer states it is safe to sew the mesh holes, provider needs to obtain written documentation from manufacturer to keep on file. Provider received completed individual plans of care for children with documented special health care needs. A nonporous diaper changing pad was also observed. Outdoor play space was monitored. Provider stated that she blocks access to the deck stairs with a gate when they play outside and stated that she will move the wood splitter away from the designated play area.
