Discussed with provider the following- ___-Observed ceiling in kitchen. Hole was repaired and observed some water damage/peeling paint on ceiling. Per providers statement she is going to repair remainder of ceiling. -observed prescription medication in providers bedroom (unlocked bedroom) and one prescription medication in kitchen. Reminded provider importance of ensuring all medications are in a secure place out of reach if children. During inspection she put them away. -Observed outside play area in side of home and emphasized the importance of cleaning all hazards and setting up a fence/barrier due to the busy street in front of home and the parking lot in the back. Reminded provider she may not use parking lot in the back of home for outside play.
