Program not in compliance with ensuring that infants are placed to sleep on a snug fitting crib mattress with tightly fitted sheets when in mobile infant room - one crib sheet was observed to be very large and loose for the mattress. Another mattress did not fit the crib properly leaving gaps at the rail and the mattress was able to move in the crib. Crib sheet in one crib was visibly soiled. Another pack n play style crib was observed with staining on mattress and sides but was not in use at time of investigation.


